Also, I understand this is only a parcel division which conveys certain rights under the applicable local land division ordinance and the State Land Division Act (formerly the subdivision control act P.A. 288 of 1967, as amended (by P.A. 591 of 1996 and P.A. 87 of 1997), MCL 560.101 et.seq.) and does not include any representation or conveyance of rights in any other state zoning ordinance, deed restrictions or other property rights. Finally, even if this division is approved, I understand local ordinances and state acts change from time to time, and if changed and the divisions made do not comply with the new requirements, unless deeds representing the approved divisions are recorded with the Register of Deeds or built upon before the changes to the laws are made, application for division approval must be made again.
